LOCAL LAW NO. 7 OF 1962

A LOCAL LAW CREATING THE POSITION OF DIRECTOR OF URBAN RENEWAL IN THE EXEMPT CLASS OF THE MUNICIPAL CIVIL SERVICE, PROVIDING FOR THE MANNER OF HIS APPOINTMENT, TERM OF OFFICE, AND FIXING THE SALARY THEREOF.

BE IT ENACTED BY THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK.

SECTION 1. CREATION OF POSITION. THERE SHALL BE IN THE CITY OF PLATTSBURGH, A DIRECTOR OF URBAN RENEWAL, WHICH OFFICE SHALL BE IN THE EXEMPT CLASS OF THE MUNICIPAL CIVIL SERVICE.

SECTION 2. THE DIRECTOR OF URBAN RENEWAL SHALL BE APPOINTED BY THE MAYOR, SUBJECT TO CONFIRMATION BY THE COMMON COUNCIL. IN ACCORDANCE WITH THE PROVISIONS OF SECTION 10 OF CHAPTER 269 OF THE LAWS OF 1902, THE CONCURRENCE OF THREE ALDERMEN SHALL BE DEEMED A CONFIRMATION.


SECTION 3. TERM OF OFFICE. THE TERM OF OFFICE OF SUCH DIRECTOR OF URBAN RENEWAL SHALL BE AT THE PLEASURE OF THE COMMON COUNCIL, AND SAID DIRECTOR MAY BE REMOVED BY A MAJORITY VOTE OF SAID COMMON COUNCIL.

SECTION 4. SALARY. THE SALARY OF SAID URBAN RENEWAL DIRECTOR SHALL BE THE SUM OF SEVENTY-SIX HUNDRED (\$7600.00) DOLLARS PER YEAR, PAYABLE IN THE SAME MANNER AS THAT OF OTHER CITY OFFICERS.

SECTION 5. TIME OF TAKING EFFECT. THIS ACT WILL TAKE EFFECT AFTER A PUBLIC HEARING AND APPROVAL BY THE MAYOR.

ON ROLL CALL, ALDERMEN BOOTH, BEAUVAIS, QUINN, SABOURIN, BRANON AND FLYNN VOTED IN THE AFFIRMATIVE; NO ONE IN THE NEGATIVE, CARRIED.
