- 1. AGENDA ITEMS BROUGHT FORWARD FROM DEPARTMENTS TO BE APPROVED BY COMMITTEE AND RECOMMENDED TO COUNCIL:
  - 1. Request from Mitchell Graham to utilize the mobile stage at Harborside on September 26, 2020 at 7:00pm for a drive in "Hip Hop event. All attendees must comply with then current health and safety regulations and recommendations. There will be a Food Vendor who must comply with NYS and Clinton County Health Department guidelines. In addition the event organizer, Mitchell Graham, will be responsible for providing any additional licenses or permits and utility fees, if required.
  - 2. Request from Assistant Superintendent of Public Works Mike Bessette for Steven E Fuller Excavating Inc to close Ohio Avenue between Nevada Oval and Oklahoma Avenue. The closure is for the Ohio Ave Water Line Replacement Project. The road will be closed to all non-essential traffic between the hours of 6:30am to 3:30pm. Work will commence on August 17, 2020 and run for a duration of approximately 1 month.
  - 3. Request from the City Chamberlain to increase General Fund Estimated Revenues for the refund of the Police Department cost for the City wide camera system and to increase the Police Department Motor Vehicle appropriations to provide for the purchase, instead of leasing, of two vehicles in 2020. The budget transfers and estimated revenue recognition will provide for the total increase necessary to purchase the motor vehicles requiring no increase to the 2020 General Fund budget.
