1. Section 1. of Local Law # 3 of 1992 be and hereby is amended in its entirety to read as follows:

"Local Law No. 4 of 1977 entitled "AN ACT IMPOSING TAXES ON SALES AND USES OF TANGIBLE PERSONAL PROPERTY AND ON CERTAIN SERVICES, AND ON OCCUPANCY OF HOTEL ROOMS, ADMISSION CHARGES, AND CLUB DUES, PURSUANT TO ARTICLE 29 OF THE TAX LAW OF THE STATE OF NEW YORK", imposing sales and compensating use taxes, as amended, being Article V of Chapter 240 of the Code of the City of Plattsburgh, is hereby repealed."

2. This local law shall take effect on the first day of March, 1993.


