Section 1. Sections C-2-1 and C-2-4 of the Charter of the City of Plattsburgh be and hereby are amended to abolish the Municipal Civil Service Commission of the City of Plattsburgh.

Section 2. Pursuant to the provisions of Civil Service Law section 16(b) the Common Council of the City of Plattsburgh hereby elects to have the Civil Service Law of the State of new York, as it applies to employees of the City of Plattsburgh, administered under the jurisdiction of the Personnel Officer of the County of Clinton.

Section 3. This law is subject to approval by referendum of the electors of the City of Plattsburgh at the next special or general election held within the City of Plattsburgh.
