LOCAL LAW NO. 5 OF 1968

A LOCAL LAW AMENDING SECTIONS 52 AND REPEALING 53 OF TITLE
4 OF THE CITY CHARTER AS ADDED TO CHAPTER 269 OF THE LAWS
OF 1902 BY LOCAL LAW NO. 32 OF 1949.

BE IT ENACTED BY THE MAYOR AND THE COMMON COUNCIL OF THE
CITY OF PLATTSBURGH, NEW YORK.

SECTION 1: SECTION 52 OF TITLE 5 OF THE CITY CHARTER AS
ADDED TO CHAPTER 269 OF THE LAWS OF 1902 BY LOCAL LAW NO. 32 OF
1949 IS HEREBY AMENDED TO READ AS FOLLOWS:

"SECTION 52. ORGANIZATION: THERE SHALL CONTINUE IN THE
CITY OF PLATTSBURGH, A DEPARTMENT OF PUBLIC WORKS. SUCH
DEPARTMENT SHALL HAVE JURISDICTION OVER ALL STREETS, HIGH-
WAYS, CURBS, SIDEWALKS AND ALL PUBLIC LANDS, BUILDINGS AND
WORKS EXCEPT THOSE PUBLIC WORKS WHICH COME UNDER THE JURIS-
DICTION OF SOME OTHER DEPARTMENT. THE CITY ENGINEER SHALL
BE THE HEAD OF THE DEPARTMENT OF PUBLIC WORKS AS WELL AS
THE ENGINEER FOR THE ENTIRE CITY UNDER THE DIRECTION OF THE
COMMON COUNCIL. THERE SHALL ALSO BE A SUPERINTENDENT OF
STREETS AND PARKS WHO SHALL PERFORM SUCH DUTIES AS MAY BE
ASSIGNED TO HIM BY THE CITY ENGINEER.

SECTION 2: LAWS REPEALED: SECTION 53 OF TITLE 54 OF
TITLE 4 OF THE CITY CHARTER AS ADDED TO CHAPTER 269 OF THE LAWS OF
1902 BY LOCAL LAW NO. 32 OF 1949 IS HEREBY REPEALED.

SECTION 3: THIS ACT SHALL TAKE EFFECT AFTER PUBLIC HEARING
AND APPROVAL BY THE MAYOR .
