LOCAL LAW NO. 1 OF 1965

ENTITLED A LOCAL LAW AMENDING SECTION 2 OF LOCAL

BE IT ENACTED BY THE MAYOR AND COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK AS FOLLOWS:
