LOCAL LAW NO. 1 OF 1949.

ENTITLED AN ACT to amend Section 11 of Chapter 269 of the Laws of 1902 as amended by the various Local Laws to date and in this instance providing for the minimum and maximum compensation, rate of increase and the time of taking effect of such increases of the Chief of Police, Acting Chief of Police and the Chief Engineer of the Fire Department and further amending Section 11B of the Charter of the City of Plattsburgh providing for the minimum and maximum compensation, rate of increase and time of taking effect of such increases for police officers and firemen in the City of Plattsburgh.

BE IT ENACTED by the Mayor and the Common Council of the City of Plattsburgh, as follows:

as amended to date is hereby amended as follows:

Paragraph 10 of said section regarding the salary of the Chief of Police shall read as follows: The salary of the Chief of Police upon appointment shall be \$3000 per calendar year or any portion thereof, the same to be increased at the rate of \$100 per year until the maximum salary of \$3400 is obtained, all of which shall be payable from the Police Fund in the General Budgetary Accounts.

Paragraph 13 of said Section in respect to the salary of the Chief Engineer of the Fire Department shall read as follows:

The salary of the Fire Chief, upon appointment shall be \$3000 per calendar year or any portion thereof, the same to be increased at the rate of \$100 per year until the maximum of \$3400 per year is obtained, all of which shall be payable from the Fire Fund of the General Budgetary Accounts.

SECTION 11. Section 11B of the City Charter of the City of Plattsburgh is hereby amended as follows: The schedule of salary for the Police Department shall be as follows: to wit

The salary of police sergeants, per calendar year or any portion thereof, shall be at the rate of \$2900 per year, all of which shall be payable from the Police Fund of the General Budgetary Accounts. The salary of each regular Patrolman per calendar year, or any portion thereof, shall be as follows:

\$2400 for the first year of service, \$2500 for the second year of service, \$2600 for the third year of service, and \$2700 for the fourth year of service,

provided, however, that no earned increment may be lost and Patrolmen now receiving maximum compensation shall continue to receive maximum compensation under this act, it being the intention of this statute to provide for a \$200 yearly raise.

The schedule of salary for the Fire Department shall be as follows: The salary of the Assistant Fire Chief, per calendar year or any portion thereof, shall be \$2900 per year all of which shall be payable from the Fire Fund of the General Budgetary Accounts. The salary of each regular fireman shall be as follows:

\$2400 for the first year of service, \$2500 for the second year of service, \$2600 for the third year of service, and \$2700 for the fourth year of service,

provided however, that no earned increment may be lost and Firemen now receiving maximum compensation shall continue to receive maximum compensation under this act, it being the intention of this statute to provide for a \$200 yearly raise.

SECTION 111. Laws Repealed and Superseded. All Local Laws inconsistent with this law are hereby superseded.

SECTION IV. Time of Taking Effect. This act shall take effect as of January 21st, 1949 after public hearing and approval by the Mayor.

On roll call, Aldermen Holland, LeClair, Villoni, Croteau, Ryan and Cardi voted in the affirmative; no one in the negative, CARRIED.
