## LOCAL LAW NO. 14 of 1948

ENTITIED AN ACT to amend Section 10 of Chapter 269 of the Laws of 1902 as amended by Chapter 428 of the Laws of 1912; Local Law No. 8 of 1932; Local Law No. 15 of 1942 and Local Law No. 23 of 1942 in relation to appointive city officers and their terms of office.

BE IT ENACTED by the Mayor and the Common Council of the City of Plattsburgh, New York, as follows:

SECTION 1. Subdivision 1 of Section 10 of Chapter 269 of the Laws of 1902 as amended by Chapter 428 of the Laws of 1912; Local Law No. 8 of 1932; Local Law No. 15 of 1942 and Local Law No. 23 of 1942 is hereby amended to read as follows:

Subdivision 1. Appointive City Officers. The appointive city officers of the City of Plattsburgh, New York, except as otherwise provided for by general law, special statutes and local laws shall be a City Judge, Acting City Judge, Corporation Counsel, a City Clerk, City Chamberlain; Milk and Sanitary Inspector; Public Health nurses within the amount provided therefor in the Board of Health budget in any fiscal year; nine members of the Board of Education; a Superintendent of Schools who shall be appointed by the Board of Education; a Superintendent of Public Works, Superintendent of Public Works, Chief of Police or Acting Chief of Police; three police sargents; and such a number of patrolmen as may be deemed necessary and such special patrolmen as may be deemed necessary; Chief Engineer and Assistant Engineer of the Fire Department and regular and call firemen as may be necessary; three members who shall constitute the Municipal Civil Service Commission; nine members who shall constitute the Library Board; a Librarian and Assistant Librarian who shall be appointed by the Library Board; Sealer of Weights and Measures. The appointment of all the foregoing officers and members of the boards except as specifically stated heretofore shall be made by the Mayor with the approval of the Common Council with the further exception that

its approval to the Members of the Board of Education is not mandatory. The officers whose appointments are not otherwise specifically provided for shall be appointed by the Mayor subject to the approval of the Common Council and the approval of all appointments except as herein stated, shall mean the concurrence of three aldermen.

SECTION 2. Term of Appointive Officers. Subdivision 2 of Section 10 of the Laws of 1902 as amended by Chapter 428 of the Laws of 1912; Local Law No. 8 of 1932 and Local Law No. 15 of 1942 is hereby amended to read as follows:

Subdivision 2. Term of Office of appointive City Officers. There term of office of the City Judge, Acting City Judge, Corporation Counsel shall be for two years; each member of the Bornd of Education five years; each member of the Municipal Sivil Service Commission six years. The terms of office of all other appointive city officers shall be in adcordance with the Civil Service Law of the State of New York and the rules and regulations of the New York State Civil Service Commission and the Municipal Civil Service Commission of the City of Plattsburgh.

SECTION 3. Laws Repealed. Local Law No. 8 of 1932 and all other acts inconsistent with this Local Law are hereby repealed.

SECTION 4. Time of Taking Effect. This Local Law shall take effect immediately after public hearing and approval by the Mayor.
