- The persons authorized in Subsection B may declare a "limited snow removal emergency" when in his or her judgment it is not necessary to prohibit overnight parking on all City streets. Notice shall be given as provided in Subsection C. When a limited snow removal emergency is declared, it shall be unlawful to park vehicles in otherwise lawful parking spaces on City streets located within the following designated areas between the hours of 12:00 a.m. and 11:59 p.m.: All City streets within the area bounded by the center line of Broad Street from Durkee Street to Oak Street; the center line of Oak Street from Broad Street to Cornelia Street; the northerly bounds of Cornelia Street from Oak Street to the northerly bounds of City Hall Place; the northerly bounds of City Hall Place and Durkee Street to the center line of Broad Street; also the area bounded by the northerly and southerly bounds of Bridge Street from the intersection with City Hall Place and Durkee Street on the west to the northerly bounds of Pike Street on the east.
