LOCAL LAW NO. 1 of 1954

ENTITLED AN ACT amending Local Law No. 1 of 1953 in respect to the salaries of policemen and firemen.

BE IT ENACTED by the Mayor and Common Council of the City of Plattsburgh, New York, as follows:

Section 1. Section 1 of Local Law No. 1 of 1953, insofar as it relates to the Chief of Police and the Chief of the Fire Department, is hereby amended to read as follows:

The salary of the Chief of Police, upon appointment, shall be at the rate of \$4,150.00 for each calendar year, which annual rate shall be increased \$100.00 at the beginning of each successive service year until the maximum annual salary rate of \$4,650.00 is attained, all of which shall be payable from the General Fund Budgetary Accounts.

The salary of the Fire Chief, upon appointment, shall be at the rate of \$4,150.00 for each calendar year, which annual rate shall be increased \$100.00 at the beginning of each successive service year until the maximum annual salary rate of \$4,650.00 is attained, all of which shall be payable from the General Fund Budgetary Accounts.

Section 2. Section 2 of Local Law No. 1 of 1953, insofar as it relates to the salary of the policemen and firemen, is hereby amended to read as follows:
