

AT A REGULAR MEETING OF THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK, HELD DECEMBER 26TH, 1963.

LOCAL LAW NO. 1 OF 1964

ENTITLED A LOCAL LAW AMENDING SECTION 45-D AND 45-E OF THE CITY CHARTER, AS ADDED BY LOCAL LAWS NO. 26 AND 27 OF 1949, IN RESPECT TO PENALTIES AND INTEREST ON SPECIAL ASSESSMENTS.

BE IT ENACTED BY THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK.

SECTION 1. SECTION 45-D OF THE CITY CHARTER, AS ADDED BY LOCAL LAW NO. 26 OF 1949, IS HEREBY AMENDED TO READ AS FOLLOWS:

SECTION 45-D. NOTICE OF ASSESSMENTS. UPON RECEIVING ANY ASSESSMENT ROLL WITH THE WARRANT OR AUTHORITY TO COLLECT ASSESSMENTS OTHER THAN THOSE PROVIDED FOR IN SECTION 152 OF THE CITY CHARTER, THE CITY CHAMBERLAIN SHALL GIVE NOTICE IN THE OFFICIAL NEWSPAPER OF THE CITY OF PLATTSBURGH, OF THE RECEIPT BY HIM OF SUCH ASSESSMENT ROLL AND WARRANT, AND THAT ALL PERSONS NAMED THEREIN ARE REQUIRED TO PAY THEIR ASSESSMENT ON OR BEFORE DECEMBER 31ST, OF THE YEAR IN WHICH SAID ASSESSMENT IS LEVIED.

SECTION 2. SECTION 45-E OF THE CITY CHARTER, AS ADDED BY LOCAL LAW NO. 27 OF 1949, IS HEREBY AMENDED TO READ AS FOLLOWS:

SECTION 45-E. REAL ESTATE TO BE SOLD. IN CASE ANY OF SAID ASSESSMENTS REMAIN UNPAID AFTER THE FOREGOING PROCEEDING HAVING BEEN TAKEN, THE AMOUNT THEREOF SHALL BE ADDED TO THE AMOUNT ASSESSED AGAINST SUCH LAND FOR GENERAL CITY TAXES, AND INCLUDED IN THE NEXT GENERAL CITY TAX ROLL, AND THE WHOLE OF SUCH ASSESSMENT SHALL BE COLLECTED IN THE SAME MANNER AS GENERAL CITY TAXES, AND ALL PENALTIES AND INTEREST AGAINST SAID ASSESSMENT SHALL COMMENCE AT THE SAME TIME AS PENALTIES AND INTEREST FOR GENERAL CITY TAXES.

SECTION 3. THIS ACT SHALL TAKE EFFECT IMMEDIATELY, AND SHALL APPLY TO ALL SPECIAL ASSESSMENT ROLLS NOW IN THE HANDS OF THE CITY CHAMBERLAIN FOR COLLECTION, AFTER PUBLIC HEARING AND APPROVAL BY THE MAYOR.

ON ROLL CALL, ALDERMEN BOOTH, BEAUVAIS, QUINN, SABOURIN, BRANON AND FLYNN VOTED IN THE AFFIRMATIVE; NO ONE IN THE NEGATIVE, CARRIED.
