## LOCAL LAW NO. 10 OF 1932.

ENTITLED AN ACT to amend Section 121 of the City Charter of the City of Plattsburgh, New York, being part of Chapter 269 of the Laws of 1902 of the State of New York, providing for monthly and yearly reports to be rendered by the commissioner of public welfare.

BE IT ENACTED by the Mayor and Common Council of the City of Plattsburgh, New York, that Section 121 of the City Charter be superseded by the following:

SECTION 121. Monthly and yearly reports to be rendered by the commissioner of public welfare. The commissioner of public welfare, at the first meeting of the common council in each month, shall under oath, report in detail to the common council the expenditures authorized by him during the preceding month, which report shall specify the name and place of abode of each person receiving relief in any form and the amount thereof, which in each individual case shall be itemized to show the specific amount expended or authorized to be expended upon written order of the commissioner for rent, food, medicinal supplies, hospitalization, etc. He shall also prepare and submit to the mayor and common council an annual report of all monies authorized to be expended by him as commissioner of public welfareduring each fiscal year, which shall include a detailed statement of the names of the recipients of public relief and care and the itemized amount thereof as it applies to each individual case. Monthly and annual reports shall show, in addition to the foregoing, the names of merchants, Pentiers, hospitals, etc., and the amount each received. He shall also make and submit to the state department of charities such reports, with respect to the city public welfare district, as may be required by the state charities law and the state department of charities; also such additional reports, at such times and covering such facts as may be required by the mayor and common council. In addition to the foregoing, the commissioner of public welfare, as investigator for old age relief, shall render monthly report of the number of applications received and the number granted and the grants of relief changes, revoked or suspended and the amount of relief to the aged paid out; also such reports as may be required by the State Department of Public Welfare under Article XIV-A (Security Against Old Age Want) of the Public Welfare Law: also he shall keep such records and accounts in relation to old age relief as the state department shall prescribe and he shall make claims for reimbursement in accordance with the requirements of Section 124-e of the law above-mentioned. During the period of the Temporary Emergency Relief Act, the commissioner of public welfare shall be responsible for the administration of this act and such rules and regulations as are now in effect or may hereafter be promulgated by the Temporary Emergency Relief Administration, but only insofar as the same pertains to his department.

This local law shall take effect upon approval by the mayor.

On roll call Aldermen Holland, Roach, Raymond, Light, Spearman and Shay voted in the affirmative. No one in the negative. CARRIED.

The foregoing local law no. 10 of 1932 is hereby approved after public hearing held this 28th day of December 1932.
