

AT A REGULAR MEETING OF THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK, HELD NOVEMBER 24, 1965.

LOCAL LAW NO. 11 OF 1965

AN ACT AMENDING LOCAL LAW NO. 12 OF 1964 AS AMENDED BY LOCAL LAW NO. 4 OF 1965, ENTITLED AN ACT AUTHORIZING THE CITY OF PLATTSBURGH AND THE COUNTY OF CLINTON TO ENTER INTO A CO-OPERATIVE AGREEMENT PURSUANT TO THE PROVISIONS OF SECTION 219M OF THE GENERAL MUNICIPAL LAW, AND PRESCRIBING THE FORM AND TERMS OF SAID AGREEMENT.

BE IT ENACTED BY THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK, AS FOLLOWS:

SECTION 1: PARAGRAPH No. 1 OF THE AGREEMENT SET FORTH IN LOCAL LAW No. 12 OF 1964, AS AMENDED BY LOCAL LAW No. 4 OF 1965, IS HEREBY AMENDED TO READ AS FOLLOWS:

1. THERE SHALL BE ORGANIZED BY THE CONTRACTING PARTIES HERETO A JOINT ECONOMIC OPPORTUNITY COUNCIL.

1A. THE JOINT ECONOMIC OPPORTUNITY COUNCIL SHALL BE A QUASI-PUBLIC ORGANIZATION REPRESENTING THE CITY OF PLATTSBURGH AND THE COUNTY OF CLINTON FOR THE PURPOSE OF CONTINUING ANTI-POVERTY ACTIVITIES AND PROGRAMS.

1B. THE CITY AND COUNTY WILL EACH APPOINT TWO REPRESENTATIVES AS MEMBERS OF SAID JOINT ECONOMIC OPPORTUNITY COUNCIL.

1C. THE JOINT ECONOMIC OPPORTUNITY COUNCIL SHALL HAVE EXCLUSIVE AUTHORITY IN THE APPOINTMENT OF ITS REMAINING MEMBERSHIP.

SECTION 2. PARAGRAPH No. 4 OF THE AGREEMENT SET FORTH IN LOCAL LAW No. 12 OF 1964, IS HEREBY AMENDED AS FOLLOWS:

1. THE SAID COUNCIL SHALL HAVE THE RIGHT AND AUTHORITY TO REQUEST ASSISTANCE AND RECEIVE GRANTS UNDER THE PROVISIONS OF PUBLIC LAW No. 88-452 OR ANY OTHER STATUTE OF THE UNITED STATES OR THE STATE OF NEW YORK, WHICH MAY AUTHORIZE PUBLIC ASSISTANCE FOR PROJECTS WITHIN THE TERRITORIAL LIMITS OF THE SAID CITY AND COUNTY. THE SAID COUNCIL MAY ALSO RECEIVE AND TAKE SUCH MONIES AS MAY COME TO THEM BY APPROPRIATION FROM THE COUNTY OF CLINTON AND THE CITY OF PLATTSBURGH, OR GIFTS FROM PRIVATE CITIZENS, OR SUCH GIFTS AS MAY BE RECEIVED BY BEQUESTS.

SECTION 3. THIS LAW SHALL TAKE EFFECT AFTER A PUBLIC HEARING AND APPROVAL BY THE MAYOR.


ON ROLL CALL, ALDERMEN BOOTH, BEAUVAIS, SABOURIN, BRANON AND FLYNN VOTED IN THE AFFIRMATIVE; NO ONE IN THE NEGATIVE; (ALDERMAN DUKEN BEING ABSENT) CARRIED.
