LOCAL LAW NO. 12 OF 1966

A LOCAL LAW AMENDING SECTION 141 OF CHAPTER 269 OF
THE LAWS OF 1902, IN THIS INSTANCE, PROVIDING FOR
A TEMPORARY ACTING CITY JUDGE, IN CASES OF ABSENCE
OR DISABILITY.

BE IT ENACTED BY THE COMMON COUNCIL OF THE CITY OF
PLATTSBURGH, N. Y.

SEC: 1. SECTION 141 OF CHAPTER 269 OF THE LAWS OF 1902
AS AMENDED BY LOCAL LAW #40 OF 1949 AND LOCAL LAW NO. 4 OF 1966,
IS HEREBY AMENDED BY ADDING THE FOLLOWING PARAGRAPH.

IN SUCH CASES WHERE BOTH THE CITY JUDGE AND ACTING CITY
JUDGE ARE UNABLE TO ACT BY REASON OF ABSENCE OR OTHER DISABILITY,
THE MAYOR MAY DESIGNATE AN ATTORNEY AND COUNSELLOR AT LAW TO
PERFORM THE DUTIES OF SAID CITY JUDGE, SUCH DESIGNATION TO CEASE
UPON THE RETURN OF THE CITY JUDGE AND ACTING CITY JUDGE, OR THE
REMOVAL OF SAID DISABILITY, AND THE COMPENSATION OF SAID ATTORNEY
SHALL BE PAID ON A DAILY BASIS, NOT TO EXCEED \$100 PER MONTH.

SECTION 2: THIS ACT SHALL TAKE EFFECT AFTER PUBLIC HEARING
AND APPROVAL BY THE MAYOR.
