LOCAL LAW NO. 12 OF 1968

ENTITLED AN ACT CLASSIFYING TITLES AND POSITIONS AND PROVIDING FOR THE
MINIMUM AND MAXIMUM COMPENSATION, RATE OF ANNUAL INCREMENTS, AND TIME OF TAKING
EFFECT OF SUCH INCREMENTS, FOR VARIOUS CITY PERSONNEL.

BE IT ENACTED BY THE MAYOR AND COMMON COUNCIL OF THE CITY OF PLATTSBURGH,
NEW YORK, AS FOLLOWS:

SECTION 1. COMPENSATION OF CERTAIN CITY OFFICIALS

THE ANNUAL SALARY RATES OF THE FOLLOWING CITY OFFICIALS AND PERSONNEL SHALL BE THE AMOUNTS SHOWN BELOW:

THE WAGE RATE FOR SCHOOL CROSSING GUARD SHALL BE \$1.30 PER HOUR AND \$27.30 FOR EACH 21 HOUR WEEK, BUT NOT TO EXCEED \$1100.00 FOR EACH CALENDAR YEAR.

SUPERVISORS AND CONSTABLES SHALL BE ENTITLED TO RECEIVE THE SAME COMPENSATION FOR THEIR SERVICES AS CORRESPONDING OFFICERS IN THE TOWNS OF THE COUNTY OF CLINTON ARE ENTITLED TO RECEIVE FOR LIKE SERVICES.

INSPECTORS OF ELECTION AND OTHER ELECTION OFFICERS ENTITLED TO BE APPOINTED SHALL RECEIVE COMPENSATION WHICH IS HEREBY FIXED AS FOLLOWS: PRIMARY DAY - \$20.00; EACH REGISTRATION DAY - \$20.00; AND GENERAL ELECTION DAY - \$20.00; PARTY REPRESENTATIVES FOR ELECTIONS ENTITLED TO BE APPOINTED SHALL RECEIVE \$15.00 FOR ELECTION DAY; CUSTODIANS OF VOTING MACHINES SHALL RECEIVE \$300 FOR THEIR SERVICES FOR EACH CALENDAR YEAR.

THE WEEKLY COMPENSATION FOR BEACH MANAGER, EMPLOYED SEASONALLY, SHALL BE \$150. AND FOR THE ASSISTANT BEACH MANAGER, EMPLOYED SEASONALLY, SHALL BE \$110.

THE COMPENSATION FOR ACTING CITY JUDGE SHALL BE AT A DAILY RATE OF \$20.00

RULES FOR ADMINISTRATION OF THE PAY PLAN

SECTION 3. NEW APPOINTMENTS.

1. NEW APPOINTMENTS SHALL BE MADE AT THE A STEP OF THE APPROPRIATE SALARY GRADE TO WHICH A CLASS TITLE HAS BEEN ASSIGNED. HOWEVER, UNDER SPECIAL CONDITIONS AND SUBJECT TO THE APPROVAL OF THE MAYOR, NEW APPOINTMENTS MAY BE MADE IN THE A, B, OR C STEP WHEN SUCH ACTION IS DETERMINED TO BE IN THE BEST INTERESTS OF THE CITY.

SECTION 4. INCREMENTS.

1. UPON COMPLETION OF SUCCESSIVE YEARS OF CITY EMPLOYMENT, THE ANNUAL SALARY RATE OF EACH OFFICIAL, DEPARTMENT HEAD AND EMPLOYEE LISTED IN THE SALARY AND GRADE SCHEDULE OF SECTION 2 SHALL BE INCREASED BY ONE INCREMENT EACH FISCAL YEAR, IN THE RESPECTIVE AMOUNTS SET FORTH IN SECTION 2, UNTIL THE MAXIMUM SALARY RATES THEREIN PROVIDED ARE ATTAINED. SUCH SALARY RATES RESULTING FROM SAID INCREMENTS SHALL BE EFFECTIVE BEGINNING ON THE ANNUAL ANNIVERSARY DATE OF EMPLOYMENT OR PROMOTION.

2. THE ANNUAL SALARY RATE OF EACH OFFICIAL, DEPARTMENT HEAD AND EMPLOYEE LISTED IN THE SALARY AND GRADE SCHEDULE OF SECTION 2 SHALL BE INCREASED BY ONE INCREMENT, IN THE AMOUNTS ESTABLISHED IN SECTION 2 FOR THE RESPECTIVE POSITIONS, UPON COMPLETION OF TEN, FIFTEEN, TWENTY AND TWENTY-FIVE YEARS OF CONSECUTIVE EMPLOYMENT BY THE CITY OF PLATTSBURGH. SUCH SALARY RATES RESULTING FROM SAID INCREMENTS SHALL BE EFFECTIVE BEGINNING ON THE ANNUAL ANNIVERSARY DATE OF EMPLOYMENT WITH THE CITY OF PLATTSBURGH PROVIDED

A. THAT SUCH LONGEVITY INCREMENTS SHALL BE PAYABLE IN CONSECUTIVE ORDER FOR TEN, FIFTEEN, TWENTY AND TWENTY-FIVE YEARS OF CONSECUTIVE EMPLOYMENT BY THE CITY, AND THAT NO ONE SHALL BE ENTITLED TO MORE THAN ONE LONGEVITY INCREMENT STEP DURING ANY FISCAL YEAR, AND PROVIDED FURTHER

B. THAT REGARDLESS OF THE TOTAL NUMBER OF CONSECUTIVE YEARS OF EMPLOYMENT BY THE CITY, PERSONNEL WILL NOT BE ELIGIBLE FOR SUCH LONGEVITY INCREMENTS UNTIL THE FIRST DAY OF THE FISCAL YEAR FOLLOWING THE ONE DURING WHICH THEIR ANNUAL SALARY RATE IS THE MAXIMUM PROVIDED FOR THEIR RESPECTIVE POSITIONS IN THIS ACT, EXCEPT

C. THAT PERSONNEL WHO SHALL HAVE COMMENCED RECEIVING ONE OR MORE LONGEVITY INCREMENTS AND ARE SUBSEQUENTLY PROMOTED OR DEMOTED SHALL RECEIVE THE APPROPRIATE SALARY RATE OF THE NEW POSITION AS PROVIDED BY SECTION 5 OF THIS ACT, AND IN ADDITION SHALL BE ELIGIBLE FOR THE LONGEVITY INCREMENT OF SUCH NEW POSITION CORRESPONDING TO THAT PREVIOUSLY BEING RECEIVED; BUT ANY ADDITIONAL LONGEVITY INCREMENTS SHALL BE PAYABLE PURSUANT TO PROVISIONS OF PARAGRAPHS A AND B OF THIS SUBDIVISION.

3. THE HOURLY RATE OF EACH EMPLOYEE LISTED IN THE HOURLY WAGE RATE SCHEDULE SHALL BE INCREASED BY 2% UPON COMPLETION OF TEN, FIFTEEN, TWENTY AND TWENTY-FIVE YEARS OF CONSECUTIVE EMPLOYMENT WITH THE CITY OF PLATTSBURGH. SUCH HOURLY INCREASE SHALL BE EFFECTIVE BEGINNING ON THE ANNUAL ANNIVERSARY DATE OF EMPLOYMENT WITH THE CITY OF PLATTSBURGH.

SECTION 5. PROMOTIONS, DEMOTIONS, TRANSFERS.

1. PERSONNEL PROMOTED SHALL RECEIVE THAT SALARY IN THE RANGE DESCRIBED FOR THE POSITION TO WHICH HE OR SHE IS PROMOTED WHICH IS ONE INCREMENT OF THE NEW SALARY GRADE HIGHER THAN THE SALARY RATE HE OR SHE PREVIOUSLY WAS RECEIVING. FOR THOSE PERSONNEL RECEIVING LONGEVITY INCREMENTS, THE MAXIMUM SALARY WITHOUT LONGEVITY OF THE POSITION TITLE PREVIOUSLY HELD SHALL BE USED IN DETERMINING THE APPLICABLE SALARY RATE FOR THE PROMOTION. THEREUPON, ELIGIBILITY FOR LONGEVITY PAY SHALL BE COVERED BY THE PROVISIONS OF SECTION 4 OF THIS ACT. IN SPECIAL CASES, WHERE THE AMOUNT OF INCREASE IS INADEQUATE, THE MAYOR IS AUTHORIZED TO ADJUST THE NEW PAY RATE BY AN ADDITIONAL STEP.

2. PERSONNEL DEMOTED SHALL RECEIVE THAT SALARY IN THE LOWER CLASSIFICATION CORRESPONDING TO THE INCREMENT STEP PREVIOUSLY RECEIVED IN THE HIGHER POSITION. ELIGIBILITY FOR LONGEVITY SHALL BE GOVERNED BY THE PROVISIONS OF SECTION 4 OF THIS ACT.

3. PERSONNEL TRANSFERRED FROM ONE DEPARTMENT OR UNIT TO ANOTHER AND CONTINUING IN THE SAME POSITION TITLE SHALL RECEIVE THE SAME SALARY GRADE.

SECTION 6. PART-TIME AND TEMPORARY EMPLOYMENT.

THE COMMON COUNCIL, OR ANY OTHER OFFICER WHO MAY BE SO AUTHORIZED OR EMPOWERED BY THE COMMON COUNCIL, MAY EMPLOY PERSONS ON A PART-TIME OR TEMPORARY BASIS TO PERFORM ANY OF THE DUTIES OF THE POSITIONS LISTED IN THIS ACT.

SECTION 7. LEGAL HOLIDAYS.

CITY EMPLOYEES EMPLOYED ON AN HOURLY BASIS WHO ARE REQUIRED TO WORK ON A DAY DESIGNATED FOR THE OBSERVANCE OF A LEGAL HOLIDAY, SATURDAYS AND SUNDAYS EXCEPTED, SHALL, IN ADDITION TO A DAY'S WAGES FOR SUCH HOLIDAY, BE ENTITLED TO COMPENSATION FOR THE NUMBER OF HOURS ACTUALLY WORKED AT THEIR USUAL HOURLY RATE AS ESTABLISHED HEREIN.

SECTION 8. SUPERSESSION.


PROVISIONS OF ALL ACTS INCONSISTENT WITH THIS ACT ARE HEREBY SUPERSEDED.

SECTION 9. TIME OF TAKING EFFECT.


