LOCAL LAW NO. 13 OF 1967

A LOCAL LAW TO AMEND THE CITY CHARTER, SECTION 72 CONCERNING THE ORGANIZATION OF THE FIRE DEPARTMENT OF PLATTSBURGH.

BE IT ENACTED BY THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK AS FOLLOWS:

SECTION 1: SECTION 72 CHAPTER 269 OF THE LAWS OF 1902 (AS AMENDED) BY L. 1903, CHAPTER 449, L. 1904, CHAPTER 319, L. 1912, CHAPTER 428, L. 1915, CHAPTER 583, L.L.1925, No. 2 L. L. 1927, No. 1, L.L.1939, No.2, L.L.1949, No.36, L.L.1957 No. 1 IS HEREBY AMENDED TO READ AS FOLLOWS:

SECTION ORGANIZATION: APPOINTMENT OF MEMBERS.
72:

THE FIRE DEPARTMENT OF THE CITY OF PLATTSBURGH, NEW YORK, SHALL CONSIST OF THE CHIEF ENGINEER, 2 ASSISTANT CHIEF ENGINEERS, AND SUCH LIEUTENANTS AND SUCH FIREMEN AS IN THE JUDGMENT OF THE COMMON COUNCIL SHALL BE NECESSARY, ALL TO BE APPOINTED BY THE MAYOR WITH THE APPROVAL OF THE COMMON COUNCIL.

SECTION 2: THIS ACT SHALL TAKE EFFECT AFTER PUBLIC HEARING AND APPROVAL BY THE MAYOR.

ON ROLL CALL, ALDERMEN BOOTH, KING, DUKEN, SABOURIN, COFFEY AND ROUGEAU VOTED IN THE AFFIRMATIVE; NO ONE IN THE NEGATIVE; CARRIED.
