A local law AUTHORIZING PAYMENT OF REAL PROPERTY TAXES AND RE-LEVIES.

SECTION 1. This Local Law is enacted pursuant to the authority granted by Municipal Home Rule Law Section 10.

SECTION 2. The terms "credit card" and "issuer" have the meanings ascribed to them by New York General Business Law Section 511.

SECTION 3. The City Chamberlain of the City of Plattsburgh be and hereby is authorized to accept payment of real property tax bills, including any re-levies, by permitting a taxpayer to charge the amount due on such tax bill to his credit card, provided that, there shall be added to the amount paid on such real property tax bill a sum equal to any processing fee or discount charged by the issuer of such card when credit card charges are presented to the issuer for payment.

SECTION 4. Any taxpayer who elects to pay a tax bill by credit card shall be given separate written notice of the dollar amount of the processing fee or discount that will be added to the tax bill. Such notice shall also advise the taxpayer of the reate of interest then charged by the City on unpaid taxes, and that the rate of interest charged by the issuer of the credit card on unpaid credit card balance is likely to be considerably in excess of the rate of interest charged by the City.
