- 1. Terminology. The term "forged instrument" shall have the meaning set forth in Penal Law Sec. 170. The term "alcoholic beverage" shall have the meaning set forth in Alcoholic Beverage Control Law Sec. 3.
- 2. Presenting Forged Instrument to Purchase Alcoholic Beverage. A person shall be guilty of a violation if he presents a forged instrument that falsely represents his identity or age to a person who sells alcoholic beverages.
- 3. Possession of Forged Instrument. A person shall be guilty of a violation when with knowledge it is forged and with intent to defraud, deceive or injure another, he possesses a forged instrument.
- 4. Sentence. A person found guilty of violating Section 2 or 3 of this Law shall be sentenced to pay a fine of five hundred dollars.
