LOCAL LAW NO. 3 OF 1954

ENTITLED AN ACT amending Local Law No. 1 of 1953 and Local Law No. 3 of 1953 in this instance increasing the salary of the Librarian, Assistant Librarian and certain hourly employees of the City of Plattsburgh, .

BE IT ENACTED by the Mayor and Common Council of the City of Plattsburgh, New York as follows:

Section 1. Section 1, of Local Law No. 1 of 1953 and Local Law No. 3 of 1953 is hereby amended to read as follows:

Section 1. The salary of the Librarian, upon appointment, shall be at the rate of \$3,000 for each calendar year, which annual rate shall be increased \$100 at the beginning of each successive service year until the maximum annual salary rate of \$3,500 is obtained, all of which shall be payable from the Public Library Budgetary account provided however, that the maximum salary shall be paid to the present Librarian.

Section 2. Section 1 of Local Law No. 1 of 1953, insofar as it relates to the salary of the Assistant Librarian shall read as follows:

<u>Position</u>	<u>Column 1 Minimum</u>	<u>Column 2 Maximum</u>	<u>Column 3 Increment</u>
Assistant Librarian	\$2,350.00	\$2,750.00	\$100.00

Section 3. Section 2 of Local Law No. 1 of 1953, insofar as it relates to hourly wage rates is hereby amended to read as follows:


HOURLY WAGE RATES: Skilled laborers employed in the Public Works Department, the Water and Sewage Department, at the Municipal Airport, and in or by such other departments as may be authorized, shall receive \$1.36 per hour; semi-skilled labor shall receive \$1.31 per hour, and common laborers shall receive \$1.26 per hour; foremen shall receive \$1.56 per hour; all of which shall be payable from appropriations according to the department, activity of project for which the labor was performed.

Section 4. This act shall take effect May 14, 1954, after public hearing and approval by the Mayor.


