

- 1. Section C1-4 A of the City Code is amended in its entirety to read as follows:
 - (a) (a) C1-4 A (1) The City shall be divided into six (6) wards numbered consecutively one through six.
 - (b) (b) C1-4 A (2) The wards shall be divided into one or more election districts in accordance with the New York State Election Law.
 - (c) (c) The ward boundaries shall be as set forth on the annexed map entitled "City of Plattsburgh Ward Boundary Map Enacted by Local Law 3 of 2003" which is hereby made an appendix to Article I of the City Charter.
- 2. On or before April 1, 2003 the Corporation Counsel shall prepare a description of the ward boundaries and sign and certify same as accurately describing the boundaries depicted on the map.
- A copy of this local law together with the annexed map and the ward boundary description shall be filed with the City Clerk and the Clinton County Board of Elections.
- 4. This local law shall take effect on April 1, 2003, after approval by the Mayor and filing with the Secretary of State.
