LOCAL LAW NO.5 OF 1963

AN ACT AMENDING LOCAL LAW NO. I OF 1926 IN RELATION TO THE POWERS OF THE COMMON COUNCIL TO INCREASE COMPENSATION OF ITS OFFICERS AND EMPLOYEES, AND IN THIS INSTANCE PROHIBITING THE MAYOR AND COMMON COUNCIL FROM INCREASING THE COMPENSATION OF ELECTIVE OFFICERS DURING THE TERM OF OFFICE WHICH THEY ARE AT THAT TIME SERVING, AND PROVIDING THAT ANY INCREASE VOTED FOR ELECTIVE OFFICERS SHALL BECOME EFFECTIVE ON JANUARY IST, NEXT SUCCEEDING THE EXPIRATION OF THEIR TERM OF OFFICE.

BE IT ENACTED BY THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, AS FOLLOWS:

Section 1. Local Law No.1 of 1926 is hereby amended by adding to Section 1 the following paragraph:

THE SALARY OF NO ELECTIVE OFFICER SHALL BE INCREASE DURING THE TERM OF OFFICE WHICH HE IS BERVING, AND ANY INCREASE IN SALARY GRANTED TO ELECTIVE OFFICERS SHALL BECOME EFFECTIVE ON JANUARY IST, NEXT SUCCEDING THE EXPIRATION OF SAID TERM OF OFFICE. ANY SUCH LAW INCREASING THE PAY OF AN ELECTED OFFICER FOR THE NEXT TERM OF OFFICE SHALL BE ADOPTED ON OR BEFORE NOVEMBER IST OF THE YEAR IN WHICH IT IS INTRODUCED."

Section 2. This Act shall take effect after public hearing and approval by the Mayor.

ON ROLL CALL, ALDERMEN BOOTH, BEAUVAIS, AND QUINN VOTED IN THE AFFIRMATIVE; ALDERMEN BRANON AND FLYNN VOTING IN THE NEGATIVE; (ALDERMAN SABOURIN BEING ABSENT) CARRIED.
