LOCAL LAW NO. 5 OF 1970

ENTITLED AN ACT PROVIDING FOR THE MINIMUM AND MAXIMUM COMPENSATION RATE AND OF ANNUAL INCREMENTS, AND THE TIME FOR THE TAKING EFFECT OF SUCH INCREMENTS, FOR VARIOUS CITY PERSONNEL AND CERTAIN EMPLOYEES OF THE MUNICIPAL LIGHTING DEPARTMENT OF THE CITY OF PLATTSBURGH, NEW YORK.

BE IT ENACTED BY THE MAYOR AND COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK AS FOLLOWS:

- 1. That upon completion of the consecutive years of City Employment, hereinafter described, the annual salary rate of each employee shall be increased by 2% each period as set forth being after the completion of five, eight, ten, fifteen, twenty and twenty-five years of employment. Such salary rates resulting from said increments shall be effective on January 1st following the annual anniversary date of employment and the reaching of each increment step.
- 2. That the annual salary rate of each employee shall be increased by 2% upon completion of five, eight, ten, fifteen, twenty and twenty-five years of consecutive employment for the City of Plattsburgh. Such salary rates resulting from said increments shall be effective beginning on the January 1st, following the anniversary date of employment.
  - (a) That such longevity increments shall be payable in consecutive order for five, eight, ten, fifteen, twenty and twenty-five years of consecutive employment for the City of Plattsburgh, and that no one shall be entitled to more than one longevity increment step during any fiscal year.

## SECTION 3. Promotion, Demotions, Transfers.

1. That if a person is promoted, demoted or transferred, the salary paid shall be based upon years of service. In special cases, where the amount of increase is inadequate, the Mayor is authorized to adjust the new pay rate by an additional step.

## SECTION 4. Part-time and Temporary Employment.

That the Common Council or any other officer who may be so authorized or empowered by the Common Council, may employ persons
