1. Chapter 7 section 7-1 is hereby amended as follows:

Pursuant to sec. 10, Subdivision 4, of the Municipal Home Rule Law of the State of New York, any policeman or peace officer of the City of Plattsburgh, New York is authorized to issue an appearance ticket relating to the enforcement of any statute, local law, ordinance, rule or regulation affecting the public health, safety and welfare of the City of Plattsburgh, New York and its inhabitants, including parking restrictions imposed by the City Zoning Ordinance.

2. Chapter 7 section 7-4 is hereby amended as follows:

7-4 The Building Inspector, Housing Inspector and Municipal Code Inspector are authorized to issue an appearance ticket to enforce any statute, local law, ordinance, rule or regulation relating to health and sanitation and building, zoning and planning.

3. Chapter 7 is hereby amended to add a new section which reads as follows:

*Sec. 7-6* The Superintendent of the Department of Public Works is authorized to issue an appearance ticket to enforce any statute, local law, ordinance, rule or regulation relating to sanitation.

4. This law shall take effect immediately upon approval by the Mayor and filing with the Secretary of State.




