LOCAL LAW NO. 6 OF 1942.

ENTITLED AN ACT To Amend Section 2 of Local Law No. 5 of 1941, providing for the appointment of Investigators, Municipal Clerks, Account Clerks and Stenographer for the Department of Public Welfare, and fixing the duties and salaries therefor, in this instance providing for an increase in the salaries of two Investigators, two Municipal Clerks and a Stenographer.

BE IT ENACTED by the Mayor and Common Council of the City of Plattsburgh, New York that Section 2 of Local Law No. 3 of 1939, as amended by Local Law No. 5 of 1941, be and the same is hereby further amended, and as so amended to be superseded by the following:

Section 2. Salaries and Compensation.

Effective January 1st, 1942, the annual salary of two Investigators shall be \$1820.00, and for one Investigator \$1560.00 a year, three-fifths of such annual salary to be chargeable to and paid out of the Public Welfare Fund; and two-fifths to be chargeable to and paid out of the Old Age Fund; annual salary of one Account Clerk shall be \$1560.00 and for one Municipal Clerk (male) whose annual salary shall be \$1200.00, and for one Municipal Clerk (female) whose annual salary shall be \$1040.00, all of which shall be chargeable to and paid out of the Public Welfare Fund; for one Stenographer whose annual salary shall be \$1300.00, chargeable to and paid out of the Old Age Assistance Fund.

The total amount involved for all salaries herein authorized to be paid shall be included in the Annual Budget Estimate of the Department of Public Welfare and Old Age Assistance Fund, as an administrative expense for the year 1943, and each year thereafter. For the year beginning January 1st, 1942, the Common Council is authorized by resolution to reallocate in the Public Welfare Fund and the Old Age Assistance Fund of the General City Budget, a sum sufficient to provide for the difference in salaries affected by the increases herein authorized.


The aforementioned salaries shall be paid semi-monthly from payrolls to be certified by the Commissioner of Public Welfare and the Secretary of the Municipal Civil Service Commission, and approved for payment by the Mayor.

This Local Law shall take effect and be retroactive as of January 1st, 1942.


On roll call, Aldermen Holland, O'Connell, Gioiosa, Demary, Behan and Tyrell voted in the affirmative; no one in the negative,
