A local law AMENDING ARTICLE II SECTION C2-3A AND ARTICLE C2-4B OF THE CITY

1. Term of Office: Mayor and Councilor. Article II Section C2-3A of the City Charter of the City of Plattsburgh is amended to provide that the term of office for Mayor shall be three years and the term of office for City Councilor shall be three years.
2. Term of Office: Corporation Counsel and Constable. Article II Section C2-4B of the City Charter of the City of Plattsburgh is amended to provide that the term of office for Corporation Counsel shall be three years and the term of office for Constable shall be three years.
3. Applicability. This local law shall apply to terms of office commencing on or after January 1, 2002.




