

Regular Meeting of the Common Council of the City of Plattsburg, New York, held September 10, 1943.

PRESENT: Alderman Holland, O'Connell, Gioiosa, Demary, Behan and Tyrell.

By Alderman Holland; seconded by Alderman Behan:

LOCAL LAW NO. 7 OF 1943.

ENTITLED AN ACT creating specific titles for positions occupied by employees of the City of Plattsburg, New York, fixing their compensation and providing for vacations and sick leaves.

BE IT ENACTED by the Common Council of the City of Plattsburg, New York, as follows:

SECTION 1. There shall be in the Department of Public Welfare, the following positions which are classified in the Municipal Civil Service of the City of Plattsburg, and the occupants of which will receive compensation in accordance with the following schedules: Column 1 shows the minimum or entrance compensation; Column 2 shows the maximum compensation which may be received; Column 3 shows the rate of yearly increase until maximum compensation, as shown in Column 2 is reached:

SECTION 8. In the Department of Public Works, skilled laborers shall receive the sum of sixty-five cents (65¢) per hour, semi-skilled laborers shall receive the sum of sixty (60¢) per hour, and common laborers shall receive the sum of fifty-five cents (55¢) per hour.

SECTION 9. In the Fire Department, Call Fireman shall be paid \$100.00 per year.

SECTION 10. In the Health Department, the Dentist shall receive the sum of \$10.00 per clinic, when employed.

SECTION 11. The Building Inspector shall receive on appointment, the sum of \$1800.00 per year, with a yearly increase of \$100.00, until the maximum salary of \$2,000.00 per annum is reached, which compensation shall be payable out of the General Fund.

SECTION 12. The salary of the Superintendent of the Municipal Bathing Beach shall be \$1600.00 a year, payable out of the Park and Beach Fund.

SECTION 13. Sick leaves to be allowed at the rate of one day per month or twelve days per year, effective from January 1st, 1943, accumulative until a total of 60 days are reached. Vacations shall be allowed at the rate of fifteen days in each calendar year, the same not allowing half days Saturdays and Sundays.

SECTION 14. This Act shall not be construed as to reduce the salary or compensation of any employee whose position is hereinbefore enumerated, from the amount of salary or compensation which he or she is now receiving nor as to affect any right which may accrue to him or her before the enactment of this statute. Provided, however, that for all positions where there is a fixed minimum and maximum salary, that all increases shall become effective September 1, 1943, for persons who have occupied their respective positions for a period of more than one (1) year.

The foregoing Local Law shall take effect September 1st, 1943, after Public Hearing and approval by the Mayor.

On roll call, Alderman Holland, O'Connell, Gioiosa, Demary, Behan and Tyrrell voted in the affirmative; no one in the negative, CARRIED.

Dear Mr. Arbenger:

I hereby return to you Local Law #7 of 1943 which was certified to me for approval on the 15th day of September, 1943 by you, which bill provided for an amendment of Section 11 of the City Charter, respecting the salaries of the city officials.

This bill is hereby disapproved and vetoed for the following reasons: First: The salary increases provided for in said bill will provide compensation which is greater than that of officials performing similar duties in the County of Clinton and in cities of the same size in the State of New York. Second: The compensation provided for in this bill will be inequitable between the various persons affected by the salary increases. Third: That it will cause undue hardship upon the taxpayers of the City of Plattsburgh.

RESOLVED: That Local Law No. 7 of 1943, passed by the Common Council at its Regular Meeting held September 10, 1943, certified to the Mayor September 15, 1943, and vetoed by the Mayor October 13, 1943, and returned to the City Clerk with his objections, which were incorporated into the Minutes of the Regular Meeting of the Common Council held October 15th, 1943, and ordered laid on the table at that meeting, be ordered from the table, reconsidered and adopted as a law over the Mayor's veto, in accordance with the provisions of Section 14 of the City Home Rule Law.
