## LOCAL LAW NO. 8 OF 1947.

ENTITLED AN ACT creating the position of TREE SURGEON in the Municipal Lighting Department of the City of Plattsburgh, New York, prescribing the duties of such position and providing for the classification and compensation thereof.

BE IT ENACTED by the Common Council of the City of Plattsburgh, New York, as follows:

SECTION 1. Creation and Classification. There shall be in the Municipal Lighting Department of the City of Plattsburgh, New York, a Tree Surgeon, which position shall be classified in the Municipal Civil Service of the City of Plattsburgh, New York, in accordance with the following schedule:

Class Title.

Jurisdictional Title.

Tree Surgeon

Competitive.

SECTION 2. Duties. Tree Surgeon shall perform the following duties: Instructs assistant in the scientific planting, removal, trimming, and spraying of trees; climbs trees. Reviews government periodicals and other current literature in the field of tree surgery. Keeps records and makes reports of tree surgery activities. Performs a variety of routine labor duties when called upon.

SECTION 3. Maximum and minimum compensation and rate of increase. The holder of the position created by Section 1 of the Act shall be compensated as follows: Column 1, the minimum compensation or entrance salary; increase until the maximum is reached.

SECTION 4. Vacations and sick leave. The provisions of Sections 9, and 14 of Local Law No. 6 of 1947 shall apply with full force and effect the person holding the position created by Section 1 of this Act.

SECTION 5. Vacancies and temporary appointments. The provisions of Sections 5 and 6 of Local Law No. 5 of 1942 shall apply with full force and effect to the person holding the position created by Section 1 of this Act.

SECTION 6. Time of taking effect. This Local Law shall take effect immediately after public hearing has been had thereon and approval by the Mayor.

On roll call, Aldermen Gervais, LeClair, Giolosa, Demary, Ryan and Cardi voted in the affirmative; no one in the negative, CARRIED.
