C. APPROVING ACCESS AND MAINTENANCE EASEMENT AGREEMENT WITH COMMUNITY BANK, N.A. FOR ARNIE PAVONE MEMORIAL PARKING PLAZA PORTION OF DOWNTOWN AREA IMPROVEMENT PROJECTS

WHEREAS, the City of Plattsburgh revitalization efforts will involve several downtown area improvement projects known as the Downtown Area Improvement Projects (DAIP); and

WHEREAS, the City of Plattsburgh Common Council determined to conduct comprehensive review of the DAIP through preparation of a Generic Environmental Impact Statement (GEIS) pursuant to the State Environmental Quality Review Act (SEQRA) and Section 617.10 of Title 6 of the New York Compilation of Codes, Rules and Regulations; and

WHEREAS, the Common Council, as duly designated Lead Agency pursuant to SEQRA, conducted a thorough SEQRA review of the DAIP, including conducting scoping, preparing Draft and Final Generic Environmental Impact Statements (EIS), conducting a Public Hearing and adopting a SEQRA Findings Statement; and

WHEREAS, the Findings Statement determined, among other things, that given the demonstrated public need and benefit of the DAIP, its lack of significant adverse environmental impacts and its avoidance of such impacts by project design, location and mitigation, the decision to proceed with the Project as proposed gave due consideration to and represented a reasonable and proper balancing of environmental considerations with social, economic and other relevant considerations; and

WHEREAS, the Findings Statement further determined and certified that, consistent with social, economic and other essential considerations from among the reasonable alternatives available, the DAIP

avoids or minimizes adverse environmental impacts to the maximum extent practicable and incorporates as conditions to the Board's decision those mitigation measures that were identified as practicable; and

WHEREAS, approval from the Common Council is now needed for an Access and Maintenance Agreement with Community Bank, N.A. (Agreement), which is required to enable construction of the Arnie Pavone Memorial Parking Plaza (APMPP) to proceed;

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. The Common Council has reviewed the proposed Agreement and finds that it constitutes an integral component of the APMPP portion of the DAIP which was thoroughly reviewed under SEQRA.
- 2. The potential environmental impacts of the proposed Agreement were adequately addressed as an essential component of the APMPP portion of the DAIP in the GEIS and the Findings Statement and the proposed Agreement is not likely to result in any new or different environmental impacts than those previously considered during SEQRA review of the DAIP. Therefore, no further SEQRA review is necessary.
- 3. The Common Council authorizes and directs the Mayor, City Clerk, Director of Community Development, City Attorney and/or Special Legal Counsel to take such further actions as may be necessary to effectuate the intent of this Resolution.

Item 7H moved from Committee:

Whereas, the City of Plattsburgh proposed a concept in 2016 to secure a first round Downtown Revitalization Grant from the State of New York,

Whereas, the City was awarded the DRI grant in May of 2016 based on a concept to build retail and residential space in the Durkee Street Lot, along with partial access to the Saranac River, a green corridor, and a sculpture and performance park,

Whereas, Mayor Calnon appointed a Local Planning Commission in 2016 to develop a plan from the initial concept, with the assistance of consultants appointed by Empire State Development,

Whereas, the Local Planning Commission met for six months, conducted numerous public forums, and contacted a number of developers,

Whereas, the Local Planning Commission concluded that the market could not bear 50,000 square feet of new commercial space downtown without significant financial assistance and instead recommended a market rate residential emphasis, an arts walk and sculpture garden in the Westelcom Park across Durkee Street, and numerous other modifications to make the original plan workable and marketable,

Whereas, the City addressed the failure of the original concept to propose alternative parking to replace the initially proposed 50,000 square feet of commercial space that the City concluded could not be accommodated economically within the Durkee Parking Lot footprint, and developed a one-for-one parking replacement plan in the downtown area through the expansion of new lots downtown funded by a different state grant,

ways not inconsistent with the plan approved by Empire State Development,

Whereas, one developer, a company based in Cohoes with similar developments in other North Country and Central New York communities, responded with a proposal,

Whereas, Prime Plattsburgh agreed to develop the land to create a mixed use residential and commercial facility, a Greenspace and extension of the Arts Walk in the form of a pedestrian walkway, expanded access to the Saranac River Trail, ample parking for all the needs of residents and patrons, and 50 parking spots available for the public on the Durkee footprint,

Whereas, each of these various steps were endorsed unanimously by the respective Common Councils over the years,

Whereas, the negotiations between the funding agency and the developer resulted in a contract between Empire State Development and Prime Plattsburgh, and

Therefore, be it resolved that the Common Council continues to support the original submission of the DRI concept, the plan as modified by the Local Planning Committee and the consultants appointed by Empire State Development, the granting of a contract to Prime Plattsburgh, and the participants in 102 public forums, consultants, and previous Common Councils, and the work performed in incorporating public comment in generating the Generic Environmental Impact Statement, subject to any additional environmental review, in the firm belief that the Durkee Street Project, the Arts Walk, the expanded Saranac River Trail, the Downtown Grants Program, the developments at the Harborside, the parking plan for one-for-one parking replacement in the downtown area, and the signage and branding project for Downtown Plattsburgh are all projects in the best interest of the residents of Plattsburgh and will ensure the city's ability to continue to garner economic development funds from the State of New York to enhance the quality of life in the City of Plattsburgh

AMENDING IN ITS ENTIRETY CITY CODE SECTION 348-24 AND SETTING WATER SERVICE RATES AND ENACTING REGULATIONS FOR LEVY AND COLLECTION OF WATER CHARGES."

LOCAL LAW NO. P-2 OF 2020

BE IT ENACTED by the Common Council of the City of Plattsburgh, New York as follows:

- 1. This local law amends and restates in its entirety City Code §348-24, entitled "Schedule of Rates; Regulations (Water Services)".
- 2. If any clause, sentence, paragraph, subdivision or part of this section shall be adjudged by any court of competent jurisdiction to be invalid, such judgment, decree or order shall not affect, impair or invalidate the remainder thereof but shall be confined in its operation to the clause, sentence, paragraph, subdivision or part thereof directly involved in the controversy in which such judgment, decree or order shall have been rendered.
- 3. This law shall not affect the validity or enforceability of any water charge, interest, penalty or lien that accrued or attached before the effective date of this law.
- 4. The rates for water services and the regulations for levying and collecting water charges are as follows:

A. Service Classification No.: 1

APPLICABLE TO THE USE OF SERVICE FOR:

All customers taking service within the corporate limits of the City of Plattsburgh, for bills rendered on and after May 1, 2020

CHARACTER OF SERVICE:

Continuous

TERM:

From the date of commencement of service, pursuant to application, until 10 days written notice is given prior to the date set for discontinuance or upon discontinuance by the water department in accordance with the provisions of this Schedule of Water Service.

SPECIAL PROVISION:

Meters may be read and/or bills rendered monthly at the option of the Water Department. The terms of payment, for monthly billings are net-twenty days after date of bill. Gross amount plus interest shall be due thereafter.

All those customers who do not have water meters installed in the water service line serving their premises on the effective date of this service classification shall be billed at the rate of \$16.44/month until such time that a water meter has been set in the water service line to their premises. Thereafter, the rates for water service above set forth shall apply.

Elderly persons that qualify for the Real Property Tax Exemption shall also be exempt from the Minimum Charge for water service and be charged for only the actual gallons of water consumed.

B. Service Classification No. 3

APPLICABLE TO USE OF SERVICE FOR:

Private fire protection service within the corporate limits of the City of Plattsburgh.

TERMS:

From the date of commencement of service, pursuant to application, until thirty days written notice is given prior to the date set for discontinuance by the Water Department in accordance with provisions of this Schedule Water Service.

SPECIAL PROVISION:

The foregoing rates for private fire protection service are based on unmetered service. Water for Fire Extinguishment purposes and limited testing requirements is provided at no extra charge. However, if, in the opinion of the Water Department, the installation of a fire line meter is required, the customer shall make said installation at his own expense. The entire meter installation shall be constructed and installed according to the specifications of the Water Department. There shall be no branch connections to said fire service line other than those for fire protection service.
