7.222 ADOPTION OF LOCAL LAW P-6 OF 2022

Local Law No. P-6 of the year 2022

A local law amending Section 340-10 “Snow Emergencies” of the City Code of the City of Plattsburgh.

Be it enacted by the Common Council of the City of Plattsburgh as follows:

1. Section 340-10 “Snow Emergencies” of the City Code of the City of Plattsburgh will be amended and restated in its entirety and will read as follows:

A.

It shall be unlawful for any person to park or leave unattended a vehicle on any street of the City of Plattsburgh, New York, between the hours of 12:00 a.m. and 11:59 p.m.— which is intended to be a 24-hour period—during the period from November 1 to May 1 of the following year when a snow removal emergency has been declared and notice given under Subsections B and C.

B.

The Superintendent of the Department of Public Works, Assistant Superintendent, or the Public Works Employee on call for emergencies, is authorized to declare a snow removal emergency when in his/her judgment snow is likely to accumulate, or has accumulated, at such depths as will make snow removal difficult if vehicles are left parked on City streets.

C.

Such declaration must be made and notice given by 6:00 p.m. the effective day of the parking ban. The intent is to provide at least 6 hours’ notice of the parking ban. Notice to the public shall be given by turning on the flashing amber lights that give notice of a snow emergency and by notifying the broadcast media of the declaration of a snow emergency.

D.

The persons authorized in Subsection B may declare a "limited snow removal emergency" when in his or her judgment it is not necessary to prohibit overnight parking on all City streets. Notice shall be given as provided in Subsection C. When a limited snow removal emergency is declared, it shall be unlawful to park vehicles in otherwise lawful parking spaces on City streets located within the following designated areas between the hours of 12:00 a.m. and 11:59 p.m.: All City streets within the area bounded by the center line of Broad Street from Durkee Street to Oak Street; the center line of Oak Street from Broad Street to Cornelia Street; the northerly bounds of Cornelia Street from Oak Street to the northerly bounds of City Hall Place; the northerly bounds of City Hall Place and Durkee Street to the center line of Broad Street; also the area bounded by the

northerly and southerly bounds of Bridge Street from the intersection with City Hall Place and Durkee Street on the west to the northerly bounds of Pike Street on the east.

2. This Local Law shall take effect immediately upon approval by the Mayor and filing with the New York Secretary of State.

7.223 RESOLUTION TITLE: AUTHORIZING REVISING CAPITAL PROJECT H8130.51

WHEREAS, the Capital Program adopted January 12, 2006 included a Clinton County Compost Facility category, and

WHEREAS, the Engineering and Planning Department established a Clinton County Compost Facility Project, and

WHEREAS, the cost of the Clinton County Compost Facility Project was estimated by the Engineering and Planning Department in 2006, revised by that department in 2010 and is being revised again in 2022 by the Environment Manager, as follows:

Now therefore,

BE IT RESOLVED, by the Common Council of the City of Plattsburgh, New York, this 17th day of November, 2022, as follows:

- 1) That the amount of Two Hundred Fifty Thousand and 00/100 (\$250,000.00) Dollars has been appropriated to the Capital **2006 Clinton County Compost Facility (Project H8130.51)** for the cost of the Capital Project described and revised above remains authorized to be expended for such purpose.

- 2) That the amount of Twenty Thousand Fifty and 00/100 (\$20,050.00) Dollars of such appropriation be provided by Sewer Reserve Fund as the actual spending from project inception through October of 2010.
- 3) That the amount of Two Hundred Twenty-nine Thousand Nine Hundred Fifty and 00/100 (\$229,950.00) Dollars of such appropriation will now be provided by the Compost Plant Reserve Fund in order to complete the project.

7.224 RESOLUTION TITLE: AUTHORIZE AWARD - ORGANICS MANAGEMENT PLAN – CONSULTANT

WHEREAS, The City has organic wastes that need to be disposed including WRRF wastewater treatment residuals, food waste, paper waste, and others;

WHEREAS, Organics disposal trends, regulations, and costs are changing significantly and the City needs a long term organics management strategy that considers these factors;

WHEREAS, A Request for Proposals was distributed to solicit consultant assistance for developing such a strategy;

NOW, THEREFORE, BE IT RESOLVED, The Common Council agrees to and authorizes the execution of all necessary documents to enter into agreements with consultants as follows:

Hazen - \$98,000

CDM Smith - \$15,000

Barton & Loguidice - \$5,000

Funding will be from Capital Project H8130.51 which will need an additional appropriation of \$50,000

7.225 RESOLUTION TITLE: AWARD OF CONSULTING SERVICES FOR THE ZONING AND SUBDIVISION CODE UPDATE

WHEREAS, the City issued a Request for Proposals on August 31, 2022 for Consulting Services for a Zoning and Subdivision Code Update; and

WHEREAS, four (4) proposals were received in response to the RFP; and

WHEREAS, a Proposal Review Committee, comprised of the Chairman of the Planning Board, a member of the City Building Inspector's Office, and two members of the Community Development Department has fully evaluated the received proposals in accordance with the terms of the RFP.

NOW, THEREFORE, BE IT RESOLVED, the Common Council authorizes the Mayor to sign an agreement for Consulting Services for the Zoning and Subdivision Code Update with LaBella Associates in the amount of \$246,280. Funding to cover this contract amount has been previously authorized by the Common Council. Funding to cover a portion of this contract amount is being sought through a grant from DOS.

7.226 RESOLUTION TITLE: AEDA SERVICE AGREEMENT FOR EXPANDED SURVEY OF SARANAC RIVER TRAIL PHASE 2 IMPROVEMENTS FUNDED NYS OPRHP GRANT

WHEREAS, the NYS Office of Parks, Recreation, and Historic Preservation (OPRHP) requires the submission of a formal survey for all areas to be improved with OPRHP funding; and

WHEREAS, a formal survey of the improvements to be implemented with a \$500,000 OPRHP attached to Phase 2 of the Saranac River Trail (SRT2) was submitted to OPRHP in 2016; and

WHEREAS, substantial changes to the footprint of the SRT2 improvements funded by the \$500,000 OPRHP grant were subsequently implemented during the SRT2 design process but a revised formal survey of the expanded footprint was not completed.

NOW, THEREFORE, BE IT RESOLVED, the Common Council authorizes the Mayor to execute a service agreement with Architectural & Engineering Design Associates, P.C. (AEDA) for completion of an expanded survey of SRT2 improvements funded by that project's \$500,000 OPRHP grant for a fee not to exceed \$5,350. Funding to be provided by capital project H5110.58 (2016 Saranac River Trail – Phase II).

7.228 RESOLUTION TITLE: AUTHORIZING HOLIDAY DISPLAYS IN TRINITY PARK
